Live Teaching School and Home Agreement

Pupils at Home

- Pupils' parents/carers will be spoken to at the start of each live session.
- The child should only be seen in a public area of the house. The child is not to be alone in a bedroom, if this were to be the case, the child must be asked to move to another part of the home.
- The child should be appropriately dressed.

Within School

- All live sessions must and will be carried out using school equipment only.
- Planning and structure of the sessions will be shared with the Senior Leadership Team.
- Live sessions are recorded, however they will be destroyed when school reopens.
- SLT are given permission to view recordings or listen to audio recordings of the live sessions.
- Recordings and notes to be kept in line with GDPR.
- SLT may contact parents/carers to gain feedback regarding live sessions.
- The staff member delivering sessions should be able to be seen and/or heard at all times.
